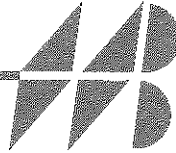

Libel are legal claims for false statements of fact about a person that are printed, broadcast, spoken or otherwise communicated to others and it harms the reputation of the person against whom the statement are made. These statements are highly defamatory and injurious to First Tek's reputation in the market and have caused continuous damages.

These references to First Tek remain posted on http://www.myvisajobs.com/Visa-Sponsor/First-Tek-Technologies/196321_Review.htm. By way of this letter First Tek is requesting that any and all references to First Tek be immediately removed not only from http://www.myvisajobs.com/Visa-Sponsor/First-Tek-Technologies/196321_Review.htm, www.myvisajobs.com entirely. You are requested to kindly delete any references to First Tek


since they are defamatory in nature and harming First Tek's reputation, thus leading to damages by way of losing current employees and rendering First Tek unable to hire prospective employees who have viewed these statements. These false statements are also damaging to First Tek's brand name with their current and potential customers.

Although First Tek respects free speech, it will not tolerate derogatory and defamatory false remarks by anonymous users against its reputation leading to damages by way of loss of revenues. These statements may be made by competitors who are losing business to First Tek. These remarks posted on http://www.myvisajobs.com/Visa-Sponsor/First-Tek-Technologies/196321_Review.htm were and are false and clearly actionable in a court of law. The discussion of First Tek on www.myvisajobs.com is an unauthorized use of the First Tek company name and portrays First Tek in a false and negative light. If you do not delete the references regarding First Tek from your website immediately upon receipt of this letter, and confirm so in writing, First Tek reserves its right to take action against www.myvisajobs.com for libel.

In order to avoid legal action in this matter, I also request that you immediately provide me with any and all identifying information currently in your possession with regard to the individuals who posted such derogatory and defamatory false remarks, including but not limited to names, last known addresses and e-mail addresses. Should you fail to do so within five (5) days of the date of receipt of this letter, I am prepared to file the appropriate subpoenas to compel production of the requested information.

I hope you realize the harm that has been caused by the users of www.myvisajobs.com to the reputation of First Tek. It is in your interest that you delete all references to First Tek in the discussion forums of www.myvisajobs.com.
